Request for Qualifications Construction Engineering North Schuyler Avenue ADA & Lighting Upgrades Project City of Kankakee, Illinois

The City of Kankakee is requesting qualifications from qualified Consulting Engineering Firms/Teams to perform Construction Engineering services for the North Schuyler Avenue Streetscape Project. The project is located on Schuyler Avenue between Locust Street and Merchant Street in Kankakee, IL.

The services to be provided under this project are described in the Scope of Services section of this proposal. All work must be in accordance with FHWA, IDOT and City standards as required for approval.

The Project Scope/Description:

This work will comprise of periodic onsite construction observation, field inspection reports to be performed at every site visit, documentation of Field Issues and Amendment thereto, Project Progress Photos to be performed at every visit, Pay Request Summaries, generate punch list and see punch list items through completion, project closeout. As-built notes marked up on Original "For Construction" plans,

The improvements will connect, better service and stabilize the existing business district, as well as address ADA compliance issues.

The project will include the replacement of the existing failing light fixtures with installation of new street lighting in order to enhance public safety. Furthermore, the lighting will tie into the new Metro Transfer Center which is the hub for the local public transit agency. The site of this hub is scheduled for improvement and will be constructed at the NE corner of Chestnut and Schuyler Avenue. The City anticipates an increase to pedestrian and bicycle traffic in this area. Therefore, replacing the existing light poles which are structurally unsound will mitigate the public safety issues in this area of the city.

This project will also identify ADA non-compliant public areas that were identified in the City's ADA Transition Plan which was submitted and approval by the Office of the Attorney General in 2019 as a result of the violation letter received from their office. Finally, the City of Kankakee is defined as an underserved area, as well as an Opportunity Zone where safe and ADA compliant access to public transportation is a necessity for all residents.

FUNDING

The funding of the Construction Engineering portion of the project will be funded solely by Rebuild Illinois Fast Track Public Infrastructure grant funds.

EVALUATION

All architectural/engineering and construction activities wholly or partially funded with Rebuild Illinois funds will be competitively procured under the terms of Federal 2 CFR 200.318 to 2 CFR 200.326, as required by Illinois' Grant Accountability and Transparency Act (GATA) (Public Act 098-0706).

Submittals should include:

This section should include the following:

- Listing of support staff, likely to work on the project

3. Project Approach

This section should include the following:

- A description of the firm's thorough understanding of the scope of the project.
- A description of the firm's proposed project team.

- 4. Similar Project Experience
 - Provide four recent examples of projects within the last five years that are similar in nature to this
 project.
 - Include a description of each project, including location, client, and scope of professional services delivered by your firm and the project team that staffed the project (project manager, resident engineer, inspector(s), etc.), duration of the project, and project cost.

A selection committee comprised of staff from the city will evaluate the SOQ's. The SOQ's will be reviewed, evaluated, and scored, using the criteria and weights defined above. The selected consultant will be notified, and a final scope and hours will be negotiated. The City of Kankakee will use SAM Exclusions, IDOT's CPO's website and the three other state CPO's websites to verify suspension and debarments actions to ensure the eligibility of the selected firm. The engineering agreement will be lump sum.
